On January 18, 2021, City Council considered Ordinance No. 2021-02, (I) ordering a General Election to be held on May 01, 2021, for the purpose of electing a Mayor and electing two (2) Councilmembers for Places 2 and 3; (II) calling a Special Election to be held on May 01, 2021, for the purpose of submitting to the voters propositions to amend the City of Jersey Village City Charter regarding: (a) eliminating Sections 1.08 and 1.09 related to the use of red light cameras, (b) amending Section 2.01 related to the number, selection, and term of office for the City Council; (c) amending Section 2.12 related to the publication of ordinances; and, (d) amending Sections 2.03, 3.01, 3.03, 4.09, 4.10, 5.01, 9.04, and 9.07 to reflect gender-neutral language; (III) providing for ballots; (IV) designating the time and place of holding such elections; (V) providing appointment of election officials and their compensation; (VI) providing for notices; (VII) providing for publication; (VIII) providing for a runoff election, if required; (IX) providing for severability; and, (X) providing an effective date.

After discussion, Ordinance 2021-02 was approved with amendments to Section 3, Proposition B as follows:

In the event of the approval of this proposition, Article II, Section 2.01 of the City Charter shall be amended to read as follows, with additions being underlined and deletions being stuck through:

### "Sec. 2.01. – Number, selection and term of office.

The council shall be composed of a mayor and five (5) other councilmembers, each of whom, unless sooner removed under the provisions of this Charter or the laws of the State of Texas, shall serve for a term of two (2) years or until **his** <u>a</u> successor has been elected and installed. The members of the council, other than the mayor, shall be elected to and occupy a place on the council, such places being numbered One, Two, Three, Four and Five, respectively. Places One, Four and Five on the council shall be

filled by **popular <u>majority</u>** vote each even-numbered year, and places Two and Three on the council shall be filled by **popular** <u>majority</u> vote each odd-numbered year. The office of mayor shall be filled by **popular** <u>majority</u> vote each odd-numbered year.

No person shall serve more than three (3) consecutive two-year terms as mayor, nor more than four (4) consecutive two-year terms as councilmember or a combination of mayor/councilmember. Any portion of a term served shall count in calculating the total number of consecutive terms served. No person who has served four (4) consecutive terms as councilmember or mayor/councilmember shall hold office as mayor within the one-year period following the said four (4) terms of service.

### Mayor Councilmember, Place 2 Councilmember, Place 3

<u>Section 2</u>. No person's name shall be placed upon the official ballot as a candidate for any of the above-mentioned positions unless and until such person shall have filed a sworn application, as provided by the laws of the State of Texas, with the City Secretary of the City at the Municipal Government Center, located at 16327 Lakeview Drive, Jersey Village, Texas 77040, not later than five o'clock (5:00) p.m. on February 12, 2021. The City Secretary shall note on the face of each such application the date and time of its filing. Such application shall include the position the candidate is seeking.

Except as otherwise **provided** <u>required</u> by law or this Charter, the city secretary shall give notice of the enactment of every ordinance imposing any penalty, fine or forfeiture for any violation of any of its provisions, and of every other ordinance required by law or this Charter to be published, by causing said ordinance, or its caption and penalty, to be published <u>(i)</u> at least one time within ten (10) days after passage thereof in the official newspaper of the city, or (ii) by posting on the municipal bulletin board for City Council agendas at City Hall and on the city's internet website continuously for twenty (20) days after passage. Except as otherwise required by law or this Charter, any requirement of the city council, or any board, department or official of the city, to provide notice with respect to any real or personal property, act, event, hearing, or other occurrence, by advertisement or notice, publication of such advertisement or notice on the municipal bulletin board and on the city's internet website, continuously for at least seventy two (72) hours or for such other longer time frame for advertisement or prescribed by law, if any, shall be sufficient public notice."

Amending Sections 2.03, 3.01, 3.03, 4.09, 4.10, 5.01, 9.04, and 9.07 of the City Charter to provide for gender-neutral language.

# SHALL THE JERSEY VILLAGE CHARTER BE AMENDED BY REPLACING GENDER SPECIFIC LANGUAGE WITH GENDER NEUTRAL LANGUAGE IN SECTIONS 2.03, 3.01, 3.03, 4.09, 4.10, 5.01, 9.04, AND 9.07?

In the event of the approval of this proposition, Sections 2.03, 3.01, 3.03, 4.09, 4.10, 5.01, 9.04, and 9.07 of the City Charter shall be amended to read as follows, with additions being underlined and deletions being stuck through:

### "Sec. 2.03. - Vacancies.

Vacancies on the council arising from any cause shall be filled by a vote of the council. The person appointed to fill any such vacancy shall possess all qualifications required for the office. There shall not be more than one (1) appointee on the council at any given time. If two (2) or more vacancies, or one (1) or more vacancies together with one (1) appointee exist at the same time, a special election shall be called to fill said vacancies and replace said appointee. However, if such vacancies occur within one hundred twenty (120) days of a regular election, such vacancies shall be filled by appointment by vote of the council. A council position filled by appointment shall be filled by election at the next city general election for the remaining year of the unexpired term or for the next full term, as the case may be. A member of the council shall be disqualified for office if **he the person** fails to meet the qualifications of office or if **he the person** is absent from three (3) consecutive or five (5) nonconsecutive regular council meetings per two-year term. Upon determination by vote of the council that a member of the council is disqualified for office, the office shall be vacant. No action taken by the council prior to such vote shall be invalid because of such disqualification."

### "Sec. 3.01. - Regular elections.

The regular election of members of the council to the positions to be filled on the council shall be held on the first election date authorized by state law on or after the first day of April of each year at a place or places designated by the council by ordinance. At every such election such voter shall not vote for more than one (1) candidate for each council position to be filled. Such election shall be ordered by the mayor, and in the event of **his the mayor's** failure to order the same, the council shall make such order. In the event of the failure of the mayor and the council to so act, such election may be called by the city secretary; and in the event of **his the city secretary** failure to act, by the County Judge of Harris County, Texas; and in the event of **his the city secretary** shall give such notice of the election as may be prescribed by law."

### "Sec. 3.03. - Filing for office.

Any person qualified to serve under the provisions of Article II hereof may be a candidate for election to a position on the council. A person who desires to be a candidate for an elective position on the city council shall file an application with the city secretary within the time prescribed by law. Such application shall clearly designate the desired position on the council and shall contain a sworn statement by the person that **the person is** fully qualified under the Constitution and laws of the State of Texas and the provisions of this Charter to hold the office **sought**. The names of all candidates who have filed for office shall be printed on the official ballot by position without party designations, in an order as provided by law."

### "Sec. 4.09. - Results of recall election.

If the majority of the votes cast at a recall election are for the recall of the officer named on the ballot, the office shall be vacant and shall be filled as specified in Article II of this Charter. An officer thus removed shall not be eligible to hold elective or appointive office in the city for a period of two years from the date of **his such** recall election."

### "Sec. 4.10. - Limitation on recall.

No recall petition shall be filed against an officer within six months after **he <u>the person</u>** takes office, and no officer shall be subjected to more than one recall election during any one term of office."

### "Sec. 5.01. - City manager.

The council shall appoint a city manager, who shall be the chief administrative and executive officer of the city. **He <u>The city manager</u>** shall be chosen by the council on the basis of the person's executive and administrative training, experience and ability.

The city manager shall be appointed for an indefinite term, and may be removed at the will of the council. The decision of the council as to such appointment or removal shall be final. The city manager shall receive such compensation as may be fixed by the council. No member of the council shall, during the term for which the member is elected and for two years thereafter, be chosen as city manager.

By letter filed with the city secretary, the city manager may designate, subject to council approval, a qualified city administrative officer to be acting city manager during **his** <u>the city manager's</u> temporary absences or disabilities. The council may revoke such designation at any time and appoint another person acting city manager to serve during such times; and if the city manager fails to make such designation, the council may appoint an acting city manager to serve during such times. The council may remove an acting city manager at any time."

### "Sec. 9.04. - Tort liability.

Before the city shall be liable for damages for the death or personal injuries of any person or for damages to or destruction of property of any kind, which does not constitute a taking or damaging of property under Article I, Section 17, Constitution of the State of Texas, the person injured, if living, or <u>the person's</u> legal representatives, if deceased, or the parent or guardian of a minor child, or the owner, <u>his the owner's</u> agent or attorney of the property damaged or destruction, duly verified by affidavit, within six months after same has been sustained, stating specifically in such written notice when, where and how the death, injury, damage or destruction occurred, and the

apparent extent of any such injury, the amount of damages sustained, the actual residence of the claimant by street and number at the date the claim is presented, the actual residence of such claimant for six months immediately preceding the occurrence of such death, injury, damage or destruction, and the names and addresses of all witnesses upon whom it is relied to establish the claim for damages. The failure to so notify the city manager within the time and manner specified herein shall exonerate, excuse and exempt the city from any liability whatsoever. No act of any officer, employee or agent of the city shall waive compliance, or preclude the city from requiring compliance, with the provisions of this section as to notice."

### "Sec. 9.07. - Personal interest in city business.

No member of the council or employee of the city shall personally engage in any business with the city nor shall have any financial interest, direct or indirect, in any commercial entity doing business with the city. The provisions of this section relating to financial interest in such commercial entity shall not apply when the ownership share of such councilmember or city employee is less than one percent of such entity. Any willful violation of this section shall constitute malfeasance in office, and any such councilmember or city employee guilty thereof shall thereby forfeit **his the person's** council position or city employment, as applicable. Further, any violation of this section with the express or implied knowledge of a person or entity doing business with the city shall render the person's contract with the city voidable by the council."

<u>Section 4.</u> The present boundaries of the City constituting one (1) election precinct, the polls shall be open for voting from seven o'clock (7:00) a.m. until seven o'clock (7:00) p.m. at the following polling place, and the following persons are hereby appointed officers to conduct the election at said polling place:

The City Secretary is hereby authorized and directed to provide a copy of this Ordinance to each judge as written notice of the appointment as required by the Texas Election Code. The City Secretary is empowered to appoint replacement judges, should the presiding and/or alternate election judge be unavailable for the election.

The Presiding Judge shall have the authority to appoint no more than sixteen (16) clerks to assist in the holding of said election, but in no event shall the Presiding Judge appoint fewer than two (2) clerks. The judges shall be paid at the rate of fourteen dollars (\$14.00) per hour; and the election clerks shall be paid at the rate of twelve dollars (\$12.00) per hour.

<u>Section 5</u>. The City Secretary is hereby appointed clerk for early voting. The appointment of deputy clerks for early voting by the City Secretary shall be in accordance with the Texas Election Code. The **Civic Center Meeting Room 16327 Lakeview Drive Jersey Village, Texas 77040** is hereby designated as the place for early voting for said election. Except as otherwise provided herein, early voting by personal appearance shall be conducted on weekdays during the hours that the City Secretary's main business office is regularly open for business, that is, from eight o'clock (8:00) a.m. until five o'clock (5:00) p.m., beginning on the twelfth (12<sup>th</sup>) day and continuing through the fourth (4<sup>th</sup>) day preceding the date of said election. The City Secretary shall provide for early voting for at least 12 hours on two weekdays, being April 26, 2021 and April 27, 2021 from seven o'clock (7:00)

The early voting clerk, in accordance with the provisions of the Texas Election Code, shall maintain a roster listing each person who votes early by personal appearance and each person to whom an early ballot to be voted by mail is sent. The roster shall be maintained in a form approved by the Secretary of State.

<u>Section 6</u>. Barbara Freeman is hereby appointed as Presiding Judge of the Early Ballot Board. In accordance with the Texas Election Code, said Presiding Judge shall appoint at least two (2) other members to said Board, and said Board shall process early voting results in accordance with said Texas Election Code.

<u>Section 7</u>. All ballots shall be prepared in accordance with the Texas Election Code. Paper ballots shall be used for early voting and for voting on Election Day. In accordance with Section 61.012 of the Texas Election Code, the City will provide in every polling place at least one voting station that is accessible to a voter with disabilities. The ExpressVote Ballot Marking Device will be provided for those voters. All expenditures necessary for the conduct of the election, purchase of materials, and the employment of all election officials are hereby authorized in accordance with the Texas Election Code.

**Section 8.** A central counting station is established at the place designated as the polling place in Section 4 hereof. The City Secretary is appointed counting station manager and tabulation supervisor. Barbara Freeman is appointed presiding judge of the central counting station. The manager may appoint such clerks to serve at the central counting station as she may deem necessary.

Section 9. The candidate for each position receiving a majority of all the votes cast at such election for such position shall be declared elected. In the event no candidate receives a majority of all votes cast at such election for any such position, a run-off election shall be ordered at which election the names of the two (2) candidates receiving the highest number of votes for such position shall be placed on the ballot in the same order as they appeared on the ballot for the general election. If a run-off election is required, it shall be held on Saturday, the  $19^{th}$  day of June 2021.

<u>Section 10</u>. Pursuant to Chapter 146 of the Texas Election Code, write-in votes cast in the election shall not be counted unless the name written in appears on the list of write-in candidates. To be entitled to a place on the list of write-in candidates, a candidate must make a declaration of write-in candidacy. Such declaration is to be filed with the City Secretary not later than 5 p.m. on the 74<sup>th</sup> day before Election Day, and all of said declarations shall be on a form prescribed by the Secretary of State.

Section 11. The order in which the names of the candidates are to be printed on the ballot shall be determined by a drawing by the City Secretary, as provided by Section 52.094 of the Texas Election Code. The City Secretary shall post a notice in her office, at least seventy-two (72) hours prior to the date on which the drawing is to be held, of the time and place of the drawing, and shall also give personal notice to any candidate who makes written request for such notice and furnishes to the City Secretary a self-addressed, stamped envelope. Each candidate involved in the drawing, or a representative designated by such candidate, shall have a right to be present and observe the drawing.

Section 12. Notice of this election shall be given in accordance with provisions of the Texas Election Code and returns of such notice shall be made as provided for in said Code. The Mayor shall issue all necessary orders and writs for such election, and returns of such election shall be made to the City Secretary immediately after the closing of the polls.

Section 13. Said election shall be held in accordance with the Texas Election Code and the Federal Voting Rights Act.

Section 14. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Jersey Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

# Strategies to Be Supported By the District

The Jersey Village Fire Department responds to emergencies related to fire, emergency medical, rescue, and hazardous material incidents. In addition, they have an active fire prevention program which provides public education to area day cares, private and public schools. The Fire Marshal's office provides plan review and daily fire code inspections to local businesses.

The Jersey Village Fire Control, Prevention, and Emergency Medical Services District (JVFCPEMSD, or District) will provide a dedicated funding source for the Jersey Village Fire Department so it can not only continue to provide excellent service but also help bring the department to a higher level of services. It will do so by incorporating the following strategies:

### 1. Personnel

The District will provide funding to recruit and retain the highest caliber employees to the department. The Department will be able to maintain the safety requirements of the National Fire Protection Association (NFPA) as it relates to personnel requirements.

2. Turnout Gear/Safety Equipment

The District will provide funding for safety equipment to ensure all members of the department are able to respond to calls while donning the necessary equipment to keep them safe.

3. Technology and Communications Equipment

To assist in keeping members of the department safe, the District will provide funding to maintain and improve technology and radio communications throughout the department. Examples of such items may include CAD systems, emergency radios, tracking incidents, and other information management needs.

4. Equipment

The District will provide funding for response equipment to include fire engines, rescue trucks, ambulances and other equipment that may be necessary. Providing funding to replace these vehicles on a scheduled and regular basis will ensure response reliability, and decrease down time in repairs.

### 5. Training

The District will provide funding for personnel to attend training classes, seminars, and schools to keep up to date with the latest technologies and methods available.

# **Evaluation of Strategies**

The following evaluation criteria will be used to ensure all funds are being utilized productively.

1. Personnel

The funding will allow for the current staffing levels to be maintained. As the city and district grows additional revenue will be generated to provide for the additional hiring of fire-fighting personnel.

2. Turnout Gear/Safety Equipment

The purchase of turn out gear for new personnel. Purchase of Self Contained Breathing Apparatus (SCBA) gear to stay at least within 2 cycles of the NFPA standards.

3. Technology and Communications Equipment

The implementation of a CAD system that allows for Fire Department tracking of incidents. The implementation of technology to assist the department in being able to access real time schematics of commercial buildings they may be entering for emergency response purposes.

4. Equipment

Measurements of this strategy will include monitoring the fleet on a yearly basis. The Department will continue the strategy of setting aside an appropriate amount of funding each year to ensure there is enough funding to replace equipment when it reaches the end of its useful life cycle.

5. Training

Department personnel will receive training on a regular basis. Personnel will be given the opportunity to attend training opportunities and/or conferences to assure new technologies and procedures are being used for the safety of Jersey Village residents.

This will also allow for all volunteers to obtain their basic fire certification with the Texas State Fire and Fire Marshalls Association as new volunteers are brought on board.

The early voting clerk's mailing address to which ballot applications and ballots voted by mail may be sent is: **16327 Lakeview Drive, Jersey Village, Texas 77040**. Applications for ballots by mail may also be received by the early voting clerk electronically at: **lcoody@jerseyvillagetx.com.** The early voting clerk, in accordance with the provisions of the Texas Election Code, shall maintain a roster listing each person who votes early by personal appearance and each person to whom an early ballot to be voted by mail is sent. The roster shall be maintained in a form approved by the Secretary of State.

<u>Section 5</u>. Paper ballots shall be used for early voting and for voting on the day of the Special Election. In accordance with Section 61.012 of the Texas Election Code, the City will provide in every polling place at least one (1) voting station that is accessible to a voter with disabilities.

<u>Section 6</u>. Notice of the Special Election shall be given in accordance with provisions of the Texas Election Code and other applicable law, and returns of such notice shall be made as provided for in said Code. The City Secretary and the Presiding Officer of the Temporary Board (the "Presiding Officer") shall issue all necessary orders and writs for the Special Election, and returns of the Special Election shall be made to the City Secretary immediately after the closing of the polls.

<u>Section 7</u>. The Presiding Officer is authorized to enter into a contract, substantially in the form attached hereto as Exhibit A, with the City to provide for a joint election as authorized by Chapter 271 of the Texas Election Code. Early voting will be conducted jointly and a single ballot shall be used.

<u>Section 8</u>. The Special Election shall be held in accordance with the Texas Election Code and the Federal Voting Rights Act.

### JOINT ELECTION AGREEMENT

**THIS JOINT ELECTION AGREEMENT** (the "Agreement") is made and entered into effect this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the City of Jersey Village, a State of Texas home rule municipal corporation (the "City"), and the Jersey Village Fire Control, Prevention, and Emergency Medical Services District (the "District") (with the City and the District each being a "Party", and collectively "Parties").

### WITNESSETH

**WHEREAS,** the City has called a General Election to be held on May 1, 2021 for the purposes of electing municipal officers, and has also called a Special Election to be held on May 1, 2021 for the purposes of approving amendments to the City's Charter; and

**WHEREAS**, the District desires to hold an election: to create the District; to institute a one and one-half percent (0.5%) sales tax to fund the District while simultaneously abolishing a one and one-half percent (0.5%) sales tax for property tax relief; and, to allow the City Council and City Manager of the City to serve as the permanent Board of Directors for the District; and

**WHEREAS**, the District wishes to join its election with the City's elections to be held on May 1, 2021; and

**WHEREAS**, the Parties shall hold such elections jointly, as hereinafter specified, if: (i) the election precincts can be served by common polling places and common election officers pursuant to Chapter 271 of the Texas Election Code; and, (ii) such common polling places and election officials are designated by the Parties; and

**WHEREAS**, holding joint elections will facilitate the orderly conduct of the elections when the location of the polling places for the voting precincts adequately and conveniently serves the affected voters of the Parties; and

**WHEREAS**, holding joint elections when appropriate by utilizing the services of the same election judges will be of public and economic benefit to the persons in the affected voting districts as well as to the Parties; and, **NOW THEREFORE**,

### THE CITY COUNCIL OF THE CITY OF JERSEY VILLAGE, TEXAS, AND THE TEMPORARY BOARD OF DIRECTORS OF THE JERSEY VILLAGE FIRE CONTROL, PREVENTION, AND EMERGENCY MEDICAL SERVICES DISTRICT AGREE AS FOLLOWS:

### AGREEMENT

**Section 1.** If the regular or special elections ordered by the Parties are to be held on the same day, such Parties agree to hold such elections jointly as authorized by Chapter 271 of the Texas Election Code, to the extent specified herein. All joint elections held pursuant to this Agreement shall be coordinated, supervised, and handled in accordance with the provisions of the Texas



**Section 2.** Nothing herein shall relieve any Party from enacting all appropriate election orders, resolutions, notices, and other pertinent documents required by or of its governing body, including, but not limited to, the preparation of necessary bilingual materials for notices. Furthermore, the Parties will utilize voting methods approved by the Secretary of State and the laws of the State of Texas.

**Section 3.** The Parties specifically agree as follows as to the joint election to be held on Saturday, May 1, 2021:

- (a) The City Secretary of the City (the "City Secretary"), shall serve as Administrator for the joint election; however, each Party remains responsible for the lawful conduct of its respective elections.
- (b) Each Party will be responsible for all required election orders, resolutions, notices, and any other pertinent documents required by its respective governing body.
- (c) Preparation of the necessary bilingual material and notices will also be the responsibility of each Party.
- (d) Early voting and Election Day voting for each Party shall be conducted at the same location. The polling place or places for the elections shall be the polling places established by the City.
- (e) There shall be one combined ballot for the elections of both Parties.
- (f) The City shall be responsible for the appointment of all election judges and election clerks.
- (g) The City Secretary shall be responsible for ordering all election supplies and ballots.
- (h) The City will contract with Election Systems and Software for the use of voting equipment that comports with Texas Election Code.
- (i) Early voting shall be conducted jointly. The City Secretary shall be appointed early voting clerk for the joint early voting. The joint early voting shall be conducted during the hours, including any extended or weekend hours, at the early voting polling place or places at which the early voting clerk regularly conducts early voting for the City. The City Secretary shall receive applications for early voting ballots to be voted by mail in accordance with the Texas Election Code.
- (j) Each Party shall canvass its own election returns.

Section 4. The joint elections contemplated herein shall be conducted at the Civic Center Auditorium, 16327 Lakeview Drive, Jersey Village, Texas, 77040. Early voting by personal appearance will be conducted at the Civic Center Meeting Room, 16327 Lakeview Drive, Jersey Village, Texas, 77040. The early voting clerk's mailing address to which ballot applications and ballots voted by mail may be sent is 16327 Lakeview Drive, Jersey Village, Texas 77040.

**Section 5.** All common costs of the election shall be shared equally between the Parties. Expenses shall include, but not be limited to, all necessary disbursements, such as election worker expenses, equipment rental expenses, and ballot programing and printing expenses. The City shall invoice the District for its share of the joint election expenses, which invoice shall be due and payable within thirty (30) days of receipt thereof.

**Section 6.** All payments required by any of the Parties hereto pursuant to this Agreement shall be made from the respective entity's current revenues at the time of the election in question. The Parties agree that the allocation of costs specified herein fairly and adequately compensates the Parties for the services required herein. All the expenses required to be paid herein shall be due on or before the thirtieth  $(30^{th})$  day after a Party receives an invoice for such expense or the service is provided, whichever occurs later. The City shall be the fiscal agent for the collection of funds and the payment of personnel jointly utilized by the Parties for the joint election.

**Section 7.** Should the City cancel an election pursuant to Section 2.051, et seq. of the Texas Election Code, it will no longer be liable for any of the expenses specified herein; but is still bound by the terms set out in Section 3 of this Agreement.

**Section 8.** All records of the joint election are to be maintained separately by the Parties holding the same, and the presiding judge shall bring the appropriate election returns, and supplies to the City Elections Administrator immediately after the polls close on Election Day and the precinct returns have been compiled.

**Section 9.** The Parties shall comply with all rules, regulations, and laws of the United State of America, the State of Texas, as they now exist or may hereafter be enacted or amended, governing elections.

**Section 10.** All notices required to be given hereunder shall be given in writing either by overnight delivery, facsimile transmission, or certified or registered mail at the respective addresses of the Parties, or at such other address as may be designated in writing by any Party. Notice given by mail shall be deemed given three (3) days after the date of mailing thereof to the following addresses:

The place of making and the place of performance of this Agreement for all purposes shall be Jersey Village, Harris County, Texas.

Section 13. The Parties agree that should any provision of this Agreement be determined to be invalid or unenforceable, such determination shall not affect any other term of this Agreement, which shall continue in full force and effect.

Section 14. This Agreement contains all the terms and conditions of the Parties relating to the subject matter hereof and is the full and final expression of the agreement between the Parties. This Agreement shall not be amended or modified without the written consent of each Party.

Section 15. The officers executing this Agreement on behalf of each Party hereby confirm that such officers have full authority to execute this Agreement and to bind their respective Party.

### JOINT ELECTION AGREEMENT

**THIS JOINT ELECTION AGREEMENT** (the "Agreement") is made and entered into effect this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the City of Jersey Village, a State of Texas home rule municipal corporation (the "City"), and the Jersey Village Crime Control and Prevention District (the "District") (with the City and the District each being a "Party", and collectively "Parties").

### WITNESSETH

**WHEREAS,** the City has called a General Election to be held on May 1, 2021 for the purposes of electing municipal officers, and has also called a Special Election to be held on May 1, 2021 for the purposes of approving amendments to the City's Charter; and

**WHEREAS,** the District desires to hold an election to continue the District for five (5) years and to approve the continuation of the sales tax funding the District for five (5) years; and

**WHEREAS,** the District wishes to join its election with the City's elections to be held on May 1, 2021; and

**WHEREAS**, the Parties shall hold such elections jointly, as hereinafter specified, if: (i) the election precincts can be served by common polling places and common election officers pursuant to Chapter 271 of the Texas Election Code; and, (ii) such common polling places and election officials are designated by the Parties; and

**WHEREAS**, holding joint elections will facilitate the orderly conduct of the elections when the location of the polling places for the voting precincts adequately and conveniently serves the affected voters of the Parties; and

**WHEREAS**, holding joint elections when appropriate by utilizing the services of the same election judges will be of public and economic benefit to the persons in the affected voting districts as well as to the Parties; and, **NOW THEREFORE**,

# THE CITY COUNCIL OF THE CITY OF JERSEY VILLAGE, TEXAS, AND THE BOARD OF DIRECTORS OF THE JERSEY VILLAGE CRIME CONTROL AND PREVENTION DISTRICT AGREE AS FOLLOWS:

### AGREEMENT

**Section 1.** If the regular or special elections ordered by the Parties are to be held on the same day, such Parties agree to hold such elections jointly as authorized by Chapter 271 of the Texas Election Code, to the extent specified herein. All joint elections held pursuant to this Agreement shall be coordinated, supervised, and handled in accordance with the provisions of the Texas Election Code. The Parties understand and agree that each Party holding a joint election shall remain responsible for the lawful conduct of the election ordered by its governing body.

Section 2. Nothing herein shall relieve any Party from enacting all appropriate election orders, resolutions, notices, and other pertinent documents required by or of its governing body, including, but not limited to, the preparation of necessary bilingual materials for notices. Furthermore, the Parties will utilize voting methods approved by the Secretary of State and the laws of the State of Texas.

Section 3. The Parties specifically agree as follows as to the joint election to be held on Saturday, May 1, 2021:

- (a) The City Secretary of the City (the "City Secretary"), shall serve as Administrator for the joint election; however, each Party remains responsible for the lawful conduct of its respective elections.
- (b) Each Party will be responsible for all required election orders, resolutions, notices, and any other pertinent documents required by its respective governing body.
- (c) Preparation of the necessary bilingual material and notices will also be the responsibility of each Party.
- (d) Early voting and Election Day voting for each Party shall be conducted at the same location. The polling place or places for the elections shall be the polling places established by the City.
- (e) There shall be one combined ballot for the elections of both Parties.
- (f) The City shall be responsible for the appointment of all election judges and election clerks.
- (g) The City Secretary shall be responsible for ordering all election supplies and ballots.
- (h) The City will contract with Election Systems and Software for the use of voting equipment that comports with Texas Election Code.
- (i) Early voting shall be conducted jointly. The City Secretary shall be appointed early voting clerk for the joint early voting. The joint early voting shall be conducted during the hours, including any extended or weekend hours, at the early voting polling place or places at which the early voting clerk regularly conducts early voting for the City. The City Secretary shall receive applications for early voting ballots to be voted by mail in accordance with the Texas Election Code.
- (j) Each Party shall canvass its own election returns.

Section 4. The joint elections contemplated herein shall be conducted at the **Civic Center** Auditorium, 16327 Lakeview Drive, Jersey Village, Texas, 77040. Early voting by personal appearance will be conducted at the Civic Center Meeting Room, 16327 Lakeview Drive, Jersev Village, Texas, 77040.
