A. The meeting was called to order by Board President, Bobby Warren at 6:18 p.m. with the following present:

Each officer of the board serves for a term of one year.

Accordingly, all officers of the FCPEMSD will serve a term of one year beginning July 18, 2022 and ending July 17, 2023.

This item is to address the requirements of LGC Section 344.103.



BACKGROUND INFORMATION:

The Fire Department roof needs to be replaced this year. The initial quotes are higher than budgeted. We budgeted \$175,000 for this project but the lowest quote we received was \$212,648 from Greater Houston Roofing, a vendor with the Texas Interlocal Purchasing System (TIPS).

The Fire Department will need additional funds of \$37,648 in order to complete this project. The Fire Department is requesting that the Fire Control, Prevention, and Emergency Medical Services District allocate \$37,648 to account 49-26-9760 Transfer to Capital Improvement Fund in order to transfer such funds to the Capital Improvement Fund line item 10-90-9760.

Staff respectfully requests approval of the proposed amendment to the Fire Control, Prevention, and Medical Services District's 2022-2023 Budget.
